



RULES & REGULATIONS

All entries must be photographs taken at Outrageous Cabins and/or in the Pigeon Forge/Sevierville/Gatlinburg area. The contest is open to individuals 18 years and older, except employees and contractors of Outrageous Cabins. The contest is void where prohibited or restricted by law. Outrageous Cabins reserves the right to cancel the contest or modify these rules at its discretion. Decisions of Outrageous Cabins will be final. No purchase is necessary. Any and all disputes will be resolved in the appropriate courts in Sevier County and subject to the laws of Tennessee. The Outrageous Photos Photo Contest is subject to all Federal, State, and Local Laws. Outrageous Cabins will use reasonable efforts to contact the winners by email, but in the event Outrageous Cabins cannot contact winners within five (5) business days from the time of judging, that participant shall be deemed void.

FORMAT

Entries are to be digital photographs and submitted electronically. Content alteration of digital files are acceptable. Cropping of photos is permitted, tonal or color corrections are acceptable. Borders, frames, text, or other graphic treatments are not permitted. Finalists will be asked to submit a high-resolution file suitable for print reproduction. Outrageous Cabins judges reserve the right to disqualify contestants who are unable to submit, upon request, a high-resolution photograph of at least 300 dpi at 8 x 12 inches (2400 x 3600 pixels.)

ENTRY

Entries are to be submitted electronically via email to Outrageous Cabins at photos@outrageouscabins.com. Include the words PHOTO CONTEST SUBMISSION in the subject line and the category in which you are entering the photo. Include your NAME, ADDRESS, and PHONE NUMBER with your submission.

CATEGORIES

1. **Cabin Images:** inside your cabin, shooting pool, kicked back watching TV – outside, grilling up a burger, front porch sittin’ with your friends and family, smoky mountain views from the hot tub
2. **Nature:** wildlife, birds, and wildflowers in natural habitat.
3. **Relaxation/On Vacation:** having fun on vacation. Activities can include individuals of any age, capturing character and spirit and a little fun!
4. **Scenic/Landscapes:** beauty shots of landscapes, sunrises, sunsets, the beautiful Smokie Mountains

FAN FAVORITE

Fan Favorite photo will be chosen based on the most Likes recorded on Facebook of the final four (4) photos selected by Outrageous Cabins judges as the contest category winners. Judging will span a five (5) day period, at the end of the quarter in which the photos are submitted. Winner will be announced in the first week of the new quarter.

DEADLINE

JUDGING

The winners of the Category Prizes will be selected by a panel of judges at Outrageous Cabins. The winner of the Fan Favorite prize will be chosen from the four winning category entries with the largest number of votes cast on Facebook. Outrageous Cabins reserves the right, at its discretion, to disqualify or discount any entrant, image, or vote connected to votes cast by unfair means. Winners will be notified by email **ONLY** by the fifth business day after the quarterly contest closes. Decision of the judges is final.
